**Notice of infringement of obligations
under Contract No. 210 dated 12th August 1998
(License series MG 242D (oil) dated 04.12.1997)**

Pursuant to the results of the unscheduled inspection and in accordance with Article 17 of the Law of the Republic of Kazakhstan No. 291-IV “On Subsoil and Subsoil Use”, dated 24th June 2010 (hereinafter - LRK), the Ministry of Oil and Gas of the Republic of Kazakhstan shall hereby notify you about the breach of obligations under Contract No. 210, dated 12th August 1998, with respect to the exploration and production of hydrocarbon resources on Tolkin field, located partially within the boundaries of Block XXX-15-F on the territory of Beyneusky District, Mangistau Region (hereinafter - Contract), with the following violations being detected:

- no information has been provided about fulfillment of Work Programs (par.6.2.10 of the Contract and sub-item.13 par. 1 art.76 of LRK);
- no annexes to the report on expenditure of monetary resources for training, indicating the names of trainees, the list of training programs, training institutions and training period, have been provided (par. 6.2.13 of the Contract);
- the obligations of instruction and training of Kazakh specialists, involved in operations under the Contract, have not been fulfilled (par. 9.3 of the License, sub-item 12 par.1 art.76 of LRK);
- the obligations of payment of past costs, amounting to 84,2 thousand USD (par. 3.5.1 of Additional Agreement No. 4, dated 28.01.2004, Additional Agreement No. 2543, dated 28.12.2007) have not been fulfilled;
- unlicensed operation of main trunk oil and gas pipelines (sub-item 1 par. 1. art.76 of LRK);
- breach of the obligations with respect to the acquisition of goods, works and services have been violated (art. 77 of LRK).

In this respect, you are obliged within 5 (five) days from the date of receipt of this Notice, i.e. until 19th July 2010, to provide explanations on reasons of non-execution of the contract terms and to provide all the necessary documents confirming the remedy of the above-mentioned violations, as well as to inform us on measures taken in order to avoid the breach of contract terms.

In case of failure to comply with the request set forth in this Notice within the above-indicated time period, the competent body has the right to terminate the Contract pursuant to par. 3 of Article 72 of LRK.
